PEST CONTROL ADVISER 2024 REGISTRATION NOTICE

Dear Pest Control Adviser,

This letter is to inform you that your Pest Control Adviser Registration for Orange County will expire on December 31, 2023. You **must register prior to conducting any PCA activities** in Orange County during the 2024 calendar year. It is unlawful to perform work in Orange County without first registering with the County Agricultural Commissioner. Please mail-in or walk-in the attached forms to complete your Orange County Pest Control Adviser Registration.

WHAT TO INCLUDE:

- 1. Completed Orange County PCA registration form (enclosed).
- 2. A copy of your current valid PCA License.
- 3. Completed Statement of Written Recommendation Form (enclosed, back page of registration form).
- 4. **Appropriate Registration fee of \$10 for In Orange County or \$5 for Out of Orange County.** We accept cash, check or money order (**Payable to: Orange County Treasurer**). Do not mail cash.
- 5. **PLEASE REMEMBER TO SIGN THE REGISTRATION FORM.**
