**PEST CONTROL RESTRICTED MATERIAL PERMIT CONDITIONS
NOTICE OF INTENT REQUIREMENTS**

WARNING - All restricted use insecticides, herbicides, rodenticides and fungicides **require a Notice of Intent (NOI)** to be submitted to the Orange County Agricultural Commissioner **at least 24 HOURS** before the proposed application when used on **Agricultural Sites** (i.e. farms, nurseries, parks in the state, county or city, rights of way, cemeteries and golf courses). NOI's are also required for the restricted rodenticides on "**Non-Agricultural**" sites such as residences, homeowner associations, greenbelts, industrial parks, or school ground sites. **If approved, these may be in the form of a weekly or monthly schedule.** The site and day must be accurately identified.

These NOI's on "Non-Agricultural" sites such as homeowner associations, greenbelts, industrial parks, school ground sites and residences must include all of the following:

- Day and site accurately identified.
- Thomas Guide map page numbers and grid location may be used to identify the site.
- Facility type must be identified, for example, residence, HOA or commercial.
- The names and addresses of the homeowner associations or businesses.
- Addresses of the residences.
- Description of the application site if not a residence. For example, greenbelts, industrial parks, private parks, landscaped slopes, etc.
- QAL/QAC responsible for application.

Any application of a pesticide on an "agricultural site" requires a written recommendation by a registered Pest Control Adviser. This includes all restricted and non-restricted materials.

6434. Notice of Intent.

(a) If the information required by (g), (h), and (i) of Section 6428 is not provided on the permit, it shall be included in the notice of intent.

(b) When a notice of intent is required by the commissioner, it shall provide the following information concerning the proposed application. If the information required by this paragraph has been provided on the permit, it may be referenced on the notice of intent.

(1) Permit number;

(2) Name and address of permittee and applicator;

(3) Location of areas to be treated and name of farm operator;

(4) Crop or commodity, or if there is no crop or commodity the site to be treated;

(5) Approximate acres or other units;

(6) Method of application;

(7) Pesticide(s);

(8) Dilution, volume per acre or other units, and dosage;

(9) Pest(s) to be controlled;

(10) Date intended application is to commence; and

(11) Location and identity of areas specified in Section 6428 which have changed since the permit was issued and which may be adversely impacted. A map or aerial photograph may be used for designating such locations.

The commissioner shall be notified at least 24 hours prior to commencing the use of a pesticide requiring a permit. The notice of intent to apply a pesticide may be submitted to the commissioner by the operator of the property to be treated, by such operator's authorized representative, or by the licensed pest control operator who is to apply the pesticide. The commissioner may allow less than 24 hours notice if he determines that because of the nature of the commodity or pest problem effective pest control cannot be attained or when 24 hours are not necessary to adequately evaluate the intended application.

Notices of Intent for applications of Restricted Materials must be **site and date specific**. The Orange County Agricultural Commissioner may deny NOIs when there is not enough information to evaluate them.
